FIVE N TWO FOOD PANTRY INFORMATION & POLICIES

1. Five N Two Food Pantry **does not discriminate** on the basis of race, ethnicity, gender, religion, sexual orientation, or economic status.
2. Five N Two Food Pantry serves **Harnett County** residents only.
3. Everyone **MUST present a picture ID** at each visit to receive food. No exceptions.
4. This form will need to be filled out each year and proof of address will need to be checked each year. The Pantry will need proof of address for all members of the household. **The following items will serve as proof:**
 - A. Picture ID with the person's name and matching address.
 - B. Current Medicaid card with the person's name and matching address.
 - C. Current bill (utility, medical, etc., or mail with the person's name and matching address.)
 - D. Birth certificate for a person under the age of 18.
 - E. We **CANNOT** accept Social Security cards.
5. Registration is based on family, not household. Any families in multifamily households are only allowed to count each family member once. Each family will need to fill out their own form.
6. Five N Two does post photos on social media. All photos taken are property of the Five N Two.
7. Outbursts of any kind including vulgar or rude misconduct will result in loss of utilizing the 5N2 Food Pantry services. We do reserve the right to refuse service.
8. Weapons of any kind are not allowed in or on the 5N2 Food Pantry property.
9. Dumping of trash on 5N2 Food Pantry property will result in legal action.
10. FAILURE TO COMPLY WITH ANY POLICY LISTED ABOVE OR POSTED AROUND THE PANTRY WILL RESULT IN YOU LOSING THE PRIVILEGE TO SHOP HERE, WE WILL MAKE YOU A BOX INSTEAD, OR YOU MAY POSSIBLY BE BANNED FROM HERE ALTOGETHER!!!!!!
